The Governors would like to take this opportunity to express their thanks and appreciation to the interim principal and all the staff for their high level of commitment and the high standards achieved both inside and outside the classroom.

STAFF DEVELOPMENT

Due to the 2020-21 staff development days were mainly focused on responding to the changing needs and requirements of the ongoing pandemic. Staff developed restart timetables and routines for September 2020, remote learning provision for January 2021 and a recovery curriculum to support pupils as they returned to the classroom in March 2021.

During this academic year, Mrs Crabbe also attended Maths Recovery Training, Miss Kernohan and Mrs McCaffery completed Sounds Write Training and Mrs Crawford attended Talk4Writing KS2 training online. Mrs McKelvey continued her training in preparation for the implementation of the new Code of Practice in Sept 2021. Miss Kernohan also completed 'New C2K Manager' training online and Mrs Crabbe updated her training as Early Professional Development teacher.

The Pastoral Care and Positive Behaviour Policies were review and following engagement by teaching staff with training materials, 'Flourishing Schools Webinars', by Joanna Brown, Safeguarding Board NI and in relation to Covid-19 recommendations by EA. We also ratified and began implementation of our new Anti-Bullying Policy.

As usual, the whole staff team completed annual training in Anaphylaxis and Asthma, Safeguarding & Child Protection and Online Safety. They also completed 'Anti-bullying' awareness training and attended Action Mental Health training 'Healthy Me' online.

Mrs Gaston completed her three-day ELKLAN: Speech and Language Support training and two Governors attended The Controlled School's Council Ethos Training.

The Curriculum

It remains the policy of the Board of Governors of Kirkinriola Primary School that all pupils will receive their full entitlement under the Northern Ireland Curriculum. Therefore, Kirkinriola Primary School offers a broad and balanced curriculum which promotes the spiritual, moral, cultural, intellectual and physical development of the pupils.

This curriculum is regularly reviewed and developed in order to help prepare pupils to become citizens who play a positive role in society. The school provides a positive, safe and active learning environment which enables pupils to be the best that they can be. Our staff team strive to maximise the potential of each pupil, whilst developing self-confidence and promoting tolerance towards others.

Special Educational Needs

In keeping with the Code of Practice and our Special Educational Needs Policy, targeted interventions are used to support any pupils who are identified as having additional needs at Kirkinriola Primary School. The staff team has developed knowledge and experience of supporting pupils with a wide range of needs including; moderate learning needs, sensory needs, auditory or visual needs, speech and language needs or social, emotional and behaviour needs. Strong Links are also maintained with other professionals and support agencies who may, in line with the Code of Practice, be engaged to further support a child's needs.

The five stages of the Code of Practice 1998

- Stage 1 – Action Plan.
- Stage 2 – School Based Intervention.
- Stage 3 – School and External Help/Support.
- Stage 4 – Statutory Assessment.
- Stage 5 – Statement of Educational Need.

If any parents wish to discuss their child's needs, they should contact their child's class teacher who may refer them on to the Special Needs Coordinator in School, **Mrs Andrea McKelvey**.

ASSESSMENT

From September 2012 the Department of Education put new arrangements in place for the statutory assessment of Communication and Using Mathematics in key Stages 1 and 2. Pupils in Year 4 and Year 7 are involved in Statutory Assessment as organised by CCEA (Curriculum Council for Examinations and Assessment). In Year 4 it is expected that children, of average ability or above, will attain Level 2 or above in Communication and using Mathematics and in Year 7, children of average ability or above, will attain level 4 or above in Communication and Using Mathematics.

School Inspection

Building Accessibility and Security

Kirkinriola Primary School is a one storey building, easily accessible and has a disabled toilet facility. Access is via a door entry intercom system. The outside of the building is monitored by CCTV. We have a safeguarding system where all visitors and staff must sign in. Only staff and visitors who have a current Enhanced Access NI certificate are allowed to work unsupervised with pupils.

Pastoral Care

In line with the policy of maximising the potential of each child, the school recognises that it has a responsibility to do everything possible to care for each pupil's emotional wellbeing.

Every member of the staff team takes responsibility for the pastoral needs of pupils in our school and any concerns are raised in the first instance with the child's class teacher. Class teachers attempt to resolve concerns with pupils and may liaise with parents or members of the Senior Leadership Team where appropriate. The Principal and class teachers encourage parents to share any information about changes in a child's circumstances, emotional wellbeing or behaviours that might impact on their ability to learn or form positive relationships in school.

When a child is sick or injured the school will administer First Aid in line with our policy. If appropriate school may contact parents and if necessary, ask the parent to come to school. Parents will be notified in any event if their child receives First Aid using the school communication systems.

In all cases it will be the school policy to act in the best interest of the pupils at all times.

Child Protection

If you have a concern about the safety of your own, or another child and you wish to make a complaint about possible child abuse, the following procedures should be used:

1. Talk to the class teacher of the child.
2. If you are still concerned, talk to the designated teacher for Child Protection, Mrs Judy Crabbe, and in her absence, the deputy designated teacher, Mrs Emily McCaffery.
3. If you still have a concern, talk to the designated governor for Child Protection, Mrs A Ramsey.
4. If you are still concerned talk or write to the Chairperson of the Board of Governors, Mr Paul McBurney
